Shipper agrees that all repairs including tires are the responsibility of the shipper and an additional \$100.00 stop-off charge plus \$75.00/hour for the time incurred during the repair will be added to the freight charges in addition to a 10% finance fee for the repair cost.

A \$550.00 truck order not used will be charged if the above named piece of equipment is not ready, un-roadworthy, or not legal for us to move.

Shipper agrees that any liability of the Carrier arising out of, or in any way relating to, this agreement shall, in no event, exceed \$500,000.00 for freight loss or damage claims. Shipper further agrees that Carrier's liability for consequential damages arising out of, or in any way relating to, freight loss, damage or delay claims shall, in no event, exceed the amount of the freight or transportation charges of the shipment in dispute or affected shipment. Carrier shall not be liable for any consequential damages which arise out of, or are in any way related to, loss of use, loss of market, or any replacement or rental charges whatsoever. Finally, Shipper agrees that Carrier shall not have any liability for freight loss, damage claims or consequential damages arising therefrom or relating to protective services, including, but not limited to, refrigeration, heaters, and/or generators, whether by Shipper or Carrier.

Payment is due within 30 days from the date of delivery. Should payment not be received within the above terms, Powersource Transportation, Inc. maintains the right to charge eighteen percent (18%) annual interest on unpaid balances, compounded monthly, together with any and all collection and attorney fees added to the above cost.

Although contract carrier service is being provided by the Carrier, the parties agree that common carrier rules of liability shall apply with respect to filing, processing and paying freight loss, damage or delay claims, except that (1) Shipper shall submit a written claim for loss of damage including loss or expenses resulting from Carrier's delay in providing service, to any shipment within thirty (30) days of the date of delivery of the shipment. (2) Any and all civil actions filed by the Shipper in any court must be filed no later than sixty (60) days from the date of delivery of the shipment of occurrence resulting in the claim. All civil actions filed as a result of disputes arising out of this agreement shall be filed in the court of proper jurisdiction in the State of Indiana shall apply unless otherwise provided for in this agreement.
